

PAYG + Reformer Terms and Conditions

- PAYG Plus Reformer is a direct debit membership agreement.
- Must be a current member of Canterbury League Club.
- Must complete a Pre-Exercise Form at the time of purchase.
- PAYG + Reformer membership is not available to Canterbury League staff members and Junior members.
- 24/7 Access into C Life is included.
- Reformer classes are limited to ten places per session.
- Bookings are essential.
- Reformer classes are inclusive with this membership provided a session booking has been secured.
- Member must request a class ticket at C-Life reception prior to attending a class.
- Member must surrender the class ticket to Instructor at the start of class session.
- Group Fitness classes on C-Life regular timetable are inclusive of PAYG + Reformer membership.
- All Group Fitness classes have a class limit capacity.
- Members must book Reformer sessions online at www.clifehealth.com.au prior to attending a session. Members will receive an automated email confirmation of the booking.
- Members are required to cancel their bookings as soon as possible in the event they are not attending a pre-booked class.
- PAYG + Reformer is a direct debit membership agreement with a minimum of 2 fortnightly debits required.
- Member must sign a Direct Debit Authority form and provide a valid account at the time of purchase.
- Fortnightly debits will continue until the Member submits a C-Life cancellation form with 14 days' notice. Form is available from C-Life reception at request.
- Debits are on a fortnightly basis on Fridays, unless a Public Holiday falls on a debit date, in which case the debit will be attempted one day prior to the Public Holiday.
- C-Life's chooses to use FFA Pysmart as the preferred debiting company on C-Life's behalf.
- A dishonour fee will be applied by FFA Pysmart to C Life Member's account for each failed debit attempted.
- A Once-Off Set Up fee will apply for new C-Life direct debit members.
- It is the Member's responsibility to provide C-Life with all current personal details and bank account details, at least 48 hours prior to a debit period, to avoid incurring dishonour fees.
- Member must adhere to all other direct debit Terms and Conditions as per Pay Smart's Welcome letter.
- An Admin fee and Pro Rata fee will apply on the day of purchase.

- A free On Hold period of 60 days per calendar year and a further 12 weeks at \$5 per fortnight is included. All On Hold requests must be submitted online 14 days in advance www.clifehealth.com.au. Backdated requests will not be accepted.
- Existing C-Life direct debit Members can choose to transfer to PAYG + Reformer membership by request at C-Life reception. Any remaining debits will transfer across to PAYG + Reformer Agreement in addition to the two minimum debits. No transfer or cancellation fee will apply during a transfer.
- PAYG + Reformer membership also includes access to Creche facility with a fee, all weights and cardio equipment, steam room, complimentary PT30 and Bio Scan consultation.
- No Upgrade applies.
- Refer A Friend benefit does qualify.
- A towel must be used on all equipment. Members can hire a towel from C Life reception for a small fee.
- Members must use the anti-bacterial products provided around the facility before and after use of any piece of equipment.
- All Canterbury League and C-Life Policies must be adhered to when visiting the facility. C Life reserves the right to suspend or cancel a membership when breaching Terms and Conditions of entry.
